A LETTER FROM TTA CEO AL LAGASSE

My heart is with TTA

It has been my life's work to help build TTA into a reputable, effective and powerful representative of our industry. Working with the board of directors, we created a strong work program (communications, government relations, meetings, research, and public relations) to serve our members.

Over the past 46 years, we grew from a few hundred members who received one monthly publication, a mostly reactive government relations program, one small annual convention, limited research, and almost no public relations, and transformed TTA into a 1,000+ member organization, with publications issued each week, a proactive government relations program, three national meetings with 1,000+ participants annually, a modest research program, and a modest public relations outreach program. We went from a \$100,000 annual budget in 1979 to a \$2 million budget before the pandemic.

Unfortunately, that more powerful representation took a major hit during the three-year, worldwide pandemic. Luckily TTA had built up our resources to withstand that hit and we are now in the process of rebuilding TTA back to its full potential.

I hope you have been reading my Backstage Chat articles in TTA's Transportation Insights newsletter (they will run through December). I've been covering my early years (1978 through 1987, so far) in more detail than I expected. That is because the work TTA (especially its presidents and boards) did back in the late 70s and all of the 80s opened the door to the widespread use of private operators in contracted services by public agencies.

It was TTA that marched in to the US Department of Transportation (DOT) in the 1970s demanding public operators stop unfairly competing against private transportation operators. That effort grew into TTA working with DOT to have DOT openly declare that public transit funds could be spent with private operators who contracted to provide publicly sponsored transportation programs. That effort helped turn an active competitor into many different contraction opportunities that many TTA members prosper from today.

TTA also marched into the US Department of Health and Human Services (HHS) in the 1980s demanding opportunity to provide publicly sponsored social service transportation (now called NEMT) by private sector transportation companies. The acceptance there was quicker and opened up greater contracting opportunities than existed at DOT, so that was another great victory for TTA that still benefits most of our members today.

When I get roasted on Thursday afternoon, I'll tell you some behind the scenes information that one just does not put into print. More importantly, I'll share some of my views on where TTA is headed and how we all need to work together to keep it the successful organization it has been since it was first formed in 1917. As we have always done, we need to continue to let the association evolve.

I have enjoyed working for TTA and with the truly great friends I have met here over the last 46 years. My past presidents were truly the best. Even so, I'll turn 69 in two months, I'm basically healthy, but I've slowed down a lot over the past two years, and I'm ready to retire. Still, my heart is with you and TTA forever.


